1 Title

This notice is the Fisheries (Interim and Annual Deemed Values) Notice 2003 Amendment Notice (No 2) 2011.

2 Commencement

This notice comes into force on 30 September 2011.

3 Application

This notice applies on and from the fishing year commencing on 1 October 2011.

4 Principal notice amended

This notice amends the Fisheries (Interim and Annual Deemed Values) Notice 2003.

5 Annual deemed values

(1) Clause 6(a)(i) is amended by—

- (a) inserting “(except for LEA3)” after “leatherjacket”; and
- (b) omitting “RBY4” and substituting “RBY1 and RBY4”.

(2) Clause 6(a)(ii) is amended by omitting—

- (a) “RIB9, RSK8, SPE1,”; and
- (b) “SSK8,”.

6 Schedule 1 amended

Schedule 1 is amended by omitting the items that correspond to each item set out in Schedule 1 of this notice and substituting, in each case, the corresponding item set out in Schedule 1 of this notice.

7 Schedule 1A amended

- (1) Schedule 1A is amended by omitting the items relating to BNS2, ELE3, ELE5, and GUR3.
- (2) The item relating to BNS1, BNS3, BNS7, BNS8, BNS10 in Schedule 1A is amended by omitting “BNS1, BNS3, BNS7, BNS8,”.
- (3) The item relating to CDL2, CDL3, CDL4 in Schedule 1A is amended by omitting “CDL2,”.
