Fisheries (Challenger Area Amateur Fishing) Amendment Regulations 2005: revoked, on 1 February 2014, pursuant to regulation 161(1)(d) of the Fisheries (Amateur Fishing) Regulations 2013 (SR 2013/482).

Pursuant to section 297 of the Fisheries Act 1996, Her Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

1 Title

(1) These regulations are the Fisheries (Challenger Area Amateur Fishing) Amendment Regulations 2005.

(2) In these regulations, the Fisheries (Challenger Area Amateur Fishing) Regulations 1986¹ are called "the principal regulations".

2 Commencement

These regulations come into force on 1 October 2005.

3 Maximum daily number of fish

Regulation 2B of the principal regulations is amended by revoking subclause (3), and substituting the following subclause:

- "(3) No person may, on any day,—
 - "(a) take from within the combined Challenger (East) Area and Marlborough Sounds Area more than 3 blue cod; or
 - "(b) possess more than 3 blue cod in that combined area; or
 - "(c) possess more than 3 blue cod taken from within that combined area."

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 2005, amend the Fisheries (Challenger Area Amateur Fishing) Regulations 1986 by replacing regulation 2B(3) to clarify that no person may, on any day, possess more than 3 blue cod in the combined Challenger (East) Area and Marlborough Sounds Area.
