1 Title

- (1) These regulations are the Fisheries (Central Area Amateur
Fishing) Amendment Regulations (No 2) 2002.

These regulations are administered in the Ministry for Primary Industries.

- (2) In these regulations, the Fisheries (Central Area Amateur Fishing) Regulations 1986¹ are called “the principal regulations”.

2 Commencement

These regulations come into force on 31 August 2002.

3 Regulation 5A revoked

The principal regulations are amended by revoking regulation 5A.

4 Offences and penalties

- (1) Regulation 6(1) of the principal regulations is amended by omitting the expression “5A(2),”.
- (2) Regulation 6(2) of the principal regulations is amended by omitting the words “3C(3)(b), or 5A(3)”, and substituting the words “or 3C(3)(b)”.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 31 August 2002, amend the Fisheries (Central Area Amateur Fishing) Regulations 1986.

The effect of the amendments is to remove the prohibition on recreational fishing, in quota management area 3, of rock lobster during the period 1 September to 30 November.
