#### 1 Title

These regulations are the Fisheries (South-East Area Amateur Fishing) Amendment Regulations (No 2) 2007.

#### 2 Commencement

These regulations come into force on 1 October 2007.

#### 3 Principal regulations amended

These regulations amend the Fisheries (South-East Area Amateur Fishing) Regulations 1986.

#### 4 New regulation 3E inserted

The following regulation is inserted after regulation 3D:

#### "3E Unattended set nets in East Otago taiapure

- "(1) A person using a set net in East Otago taiapure must, at all times, remain in the immediate vicinity of the set net.
- "(2) In this regulation, **East Otago taiapure** means the area described in the Schedule to the Fisheries (East Otago Taiapure) Order 1999."

#### **Explanatory note**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 2007, amend the Fisheries (South-East Area Amateur Fishing) Regulations 1986 by inserting *new regulation 3E*, which provides that a person using a set net in East Otago taiapure must, at all times, remain in the immediate vicinity of the set net. A person who contravenes or fails to comply with the new regulation commits an offence and is liable on summary conviction to a fine not exceeding \$10,000.
