These regulations are the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Amendment Regulations 2012.

2 Commencement

These regulations come into force on 1 May 2012.

3 Principal regulations

These regulations amend the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986 (the **principal regulations**).

4 **Regulation 3A amended (Maximum daily number of fish)** After regulation 3A(2), insert:

- "(2A) No person may, on any day,—
 - "(a) take from within the Auckland fishery management area more than 5 bluenose; or
 - "(b) possess more than 5 bluenose in that area; or
 - "(c) possess more than 5 bluenose taken from within that area."

These regulations, which come into force on 1 May 2012, amend the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986.

The amendment provides that 5 is the maximum daily number for bluenose in relation to the Auckland fishery management area.
