## Regulations

- 1 Title**  
These regulations are the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Amendment Regulations (No 3) 2008.
- 2 Commencement**  
These regulations come into force on the 28th day after the date of their notification in the *Gazette*.
- 3 Principal regulations amended**  
These regulations amend the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986.
- 4 Offences and penalties**  
Regulation 11(1) is amended by omitting “6C(1)(l)(iii)” and substituting “6C(1)(l)(iii), 6CA”.

## Explanatory note

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, make a minor technical amendment to the Fisheries (Auckland and Kermadec Areas Am-

ateur Fishing) Regulations 1986. The amendment is intended to give better effect to the amendments that were recently made to the principal regulations by the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Amendment Regulations (No 2) 2008, which introduced new measures for the protection of Hector's and Maui's dolphins.
