Fisheries (Umupuia Beach Temporary Closure) Notice 2010: revoked, on 26 October 2012 (after expiring on 16 October 2012), by clause 5 of the Fisheries (Umupuia Beach Temporary Closure) Notice 2012 (SR 2012/301).

Pursuant to section 186A of the Fisheries Act 1996, the Minister of Fisheries and Aquaculture, after complying with the requirements of that section, gives the following notice.

**2 Commencement**

This notice comes into force on 16 October 2010.

**3 Expiry**

This notice expires on the close of 15 October 2012.

**4 Umupuia Beach closed in respect of cockles for 2 years**

(1) No person may take cockles from Umupuia Beach while this notice is in force.

(2) In this clause,—

**cockle** means the mollusc *Austrovenus stutchburyi*

**Umupuia Beach** means that area of New Zealand fisheries waters that lies within an area bounded by a line that—

- (a) commences at the mean high-water springs at Te Puea at the western end of the beach known as Umupuia Beach (at 36°53.77'S and 175°05.82'E); then
- (b) proceeds in a straight line in a south-easterly direction to Whakakaiwhara Point (at 36°54.05'S and 175°05.88'E); then
- (c) proceeds along the mean high-water springs to the point of commencement.

**5 Revocation**

The Fisheries (Umupuia Beach Temporary Closure) Notice 2008 (SR 2008/363) is revoked.

### **Explanatory note**

This notice, which comes into force on 16 October 2010, prohibits the taking of cockles from Umupuia Beach for a period of 2 years.

**Notes****1 General**

**2 Status of reprints**

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

**3 How reprints are prepared**

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked

#### **4 Changes made under section 17C of the Acts and Regulations Publication Act 1989**

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as “of this section” and “of this Act”)
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
  - indentation
  - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as “the 1st day of January 1999” is now expressed as “1 January 1999”)

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
  - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
  - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
