Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 2014, revokes the Fisheries (Marsden Bank Temporary Closure) Notice 2012 (the **2012 notice**). The 2012 notice prohibited the taking of pipi from Marsden Bank. The 2012 notice is no longer necessary as the Fisheries (Marsden Bank and Mair Bank, Closure of Pipi Fishery) Notice 2014 prohibits the taking of pipi from Marsden Bank from 1 October 2014 onwards. This notice is revoked on 1 November 2014.
