Fisheries (Amateur Fishing) Amendment Regulations 1998: revoked, on 1 February 2014, pursuant to regulation 161(1)(a) of the Fisheries (Amateur Fishing) Regulations 2013 (SR 2013/482).

PURSUANT to section 89 of the Fisheries Act 1983, and sections 297 and 298 of the Fisheries Act 1996, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

1 Title and commencement

- (1) These regulations may be cited as the Fisheries (Amateur Fishing) Amendment Regulations 1998, and are part of the

Fisheries (Amateur Fishing) Regulations 1986¹ (“the principal regulations”).

- (2) These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

2 Set nets

Regulation 12(1) of the principal regulations is amended by revoking paragraph (d), and substituting the following paragraph:

- “(d) Use or possess in or adjacent to New Zealand fisheries waters any baited set net, other than a fyke net or hinaki trap.”

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after their notification in the *Gazette*, amend the Fisheries (Amateur Fishing) Regulations 1986 to allow recreational fishers to use baited fyke nets and hinaki traps.
