**1 Title**

This notice is the Fisheries (Appointment Of Commercial Fisheries Services Limited as Place for Receipt of Returns) Notice 2002.

- (b) includes all returns of that kind that are approved by the chief executive under section 296(1) of the Fisheries Act 1996 to be transmitted electronically.
