#### 1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Hokonui Rūnanga) Notice 2018.

#### 4 Customary food gathering area/rohe moana

This notice applies to the customary food gathering area/rohe moana defined by clause 2(c) of the Fisheries (South Island Customary Fishing) Notice (No. 3) 1998 (*Gazette* 1998, p 3588), which is an area from Milford Sound/Piopiotahi to Tokatā/the Nuggets.

#### Explanatory note

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice is given under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself at the end of 20 May 2023.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by the 4 Murihiku Rūnanga, of which Hokonui Rūnanga is one. The area/rohe moana is an area from Milford Sound/Piopiotahi to Tokatā/the Nuggets.

Notice is given of the reappointment of 4 Tāngata Tiaki/Kaitiaki for the area/rohe moana. The Minister of Fisheries made the reappointments at the request of Hokonui Rūnanga.

The powers of Tāngata Tiaki/Kaitiaki are set out in the regulations.

## Notes

### **1** *General*

This is a consolidation of the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Hokonui Rūnanga) Notice 2018 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

### **2** *Legal status*
