1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Ōraka-Aparima Rūnaka) Notice 2019.

2 Commencement

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself at the end of 17 September 2023.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Ōraka-Aparima Rūnaka. The area/rohe moana is an area seaward and inland from Milford Sound/Piopiotahi to Tokata Point (also known as the Nuggets).

Notice is given of the reappointment of 6 Tāngata Tiaki/Kaitiaki for the area/rohe moana. The Minister of Fisheries made the reappointments at the request of Ōraka-Aparima Rūnaka.

1 General
