#### 1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Te Rūnanga o Awarua) Notice (No 3) 2019.

# **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice is given under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself at the end of 16 September 2023.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Te Rūnanga o Awarua. The area/rohe moana is an area seaward and inland from Piopiotahi to Tokatā (Milford Sound to the Nuggets).

# **Notes**

#### 1 General
