**1 Title**

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Te Rūnanga o Moeraki) Notice 2019.

### 3 Revocation of this notice

This notice is revoked at the end of 18 December 2023.

### 4 Customary food gathering area/rohe moana

This notice applies to the customary food gathering area/rohe moana defined by clause 2(c) of the Fisheries (South Island Customary Fishing) Notice (No. 6) 1998 (*Gazette* 1998, p 4184), which is an area in North Otago from the mouth of the Waitaki River south to the mouth of the Shag River.

### 5 Reappointments

- (1) The Minister of Fisheries has appointed the following people for a further term as Tāngata Tiaki/Kaitiaki for the area/rohe moana:

### Explanatory note

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself at the end of 18 December 2023.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Te Rūnanga o Moeraki. The area/rohe moana is between the Waitaki and Shag Rivers in North Otago.

Notice is given of the reappointment of two Tāngata Tiaki/Kaitiaki for the area/rohe moana. The Minister of Fisheries made the reappointments at the request of Te Rūnanga o Moeraki.

The powers of Tāngata Tiaki/Kaitiaki are set out in the regulations.

## Notes

### **1** *General*

This is a consolidation of the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Te Rūnanga o Moeraki) Notice 2019 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

### **2** *Legal status*

A consolidation is taken to correctly state, as at its stated date, the law enacted or made by the legislation consolidated and by the amendments. This presumption applies unless the contrary is shown.
