# **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on 13 September 2017 and revokes itself on 12 September 2018.

The notice relates to Ōkārito Lagoon Mātaitai Reserve, which is on the west coast of the South Island. The tangata whenua of the area that includes the mātaitai reserve are represented by Te Rūnanga o Makaawhio.

Notice is given of the reappointment of 5 Tāngata Tiaki/Kaitiaki for the mātaitai reserve. The Minister for Primary Industries made the reappointments at the request of Te Rūnanga o Makaawhio.

The powers of Tangata Tiaki/Kaitiaki are set out in the regulations.
