# **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, amends the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Southern Bluefin Tuna) Notice 2009. The amendments update the list of international conservation and management measures that have been adopted by the Commission for the Conservation of Southern Bluefin Tuna in 2018. This notice also revokes 5 notices, which have been superseded.

#### **Notes**

#### 1 General

This is a consolidation of the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Southern Bluefin Tuna) Amendment Notice 2019 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.
