Regulations

1 Title

These regulations are the Fisheries (Satellite Vessel Monitoring) Amendment Regulations 2010.

2 Commencement

These regulations come into force on 16 December 2010.

3 Principal regulations amended

These regulations amend the Fisheries (Satellite Vessel Monitoring) Regulations 1993.

4 Interpretation

The definition of **type approval** in regulation 2 is revoked.

5 Regulation 5 revoked

Regulations 5 is revoked.

6 Registration of automatic location communicators

Regulation 6(1) is amended by omitting "is of the same type as a type approved under regulation 5 of these regulations" and substituting "complies with the standards and requirements specified under regulation 4(1)".

7 Offences and penalties

Regulation 8(1)(b)(i) is amended by omitting "type approval granted in respect of the device" and substituting "standards and requirements specified by circular issued under regulation 4(1)".

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect. These regulations, which come into force on 16 December 2010, amend the Fisheries (Satellite Vessel Monitoring) Regulations 1993.

The amendments omit the requirement for automatic location communicators to be of an approved type, and substitute the requirement for them to comply with standards and requirements specified by circular issued under regulation 4(1) of the regulations.
