Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 October 2017, revokes numerous Orders in Council that established special housing areas under the authority of the Housing Accords and Special Housing Areas Act 2013 (the **Act**).

Under section 18(1)(a) of the Act, if an Order in Council establishing a special housing area was notified in the *Gazette* on or before 15 September 2015, the special housing area was disestablished on 16 September 2016. The applicable Orders in Council are listed in *Schedule 1* of this revocation order and are all revoked on commencement of this order.

Explanatory note

Under section 18(1)(b) of the Act, if an Order in Council establishing a special housing area was notified in the *Gazette* after 15 September 2015 but before 16 September 2016, the special housing area was disestablished 12 months after that Order in Council was notified. The applicable Orders in Council are listed in *Schedule 2* of this revocation order. The last special housing area established by one of those Orders in Council was disestablished at midnight on 28 July 2017. All of those Orders in Council are revoked on commencement of this order.

The Orders in Council are being revoked because they are spent. *See* Schedule 3 of the Act for transitional provisions relating to the disestablishment of special housing areas under the Act.
