Description of The Royal Australian and New Zealand College of Psychiatrists' Peer Review Groups Activity

1 Objective

The objective of the activity is to improve the practices and competence of health professionals engaged in the activity by assessing the health services performed by those health practitioners.

2 Method

- (1) The activity is based on information derived from health practitioners who participate in the activity and who are—
 - (a) fellows of The Royal Australian and New Zealand College of Psychiatrists; or

- (b) registered with, or members of a group registered with, The Royal Australian and New Zealand College of Psychiatrists.
- (2) The activity involves—
 - (a) reviewing, analysing, and monitoring clinical work through peer review; and
 - (b) identifying and analysing adverse outcomes, in the context of peer review; and
 - (c) making recommendations on how the health practitioners who are engaging in the activity can improve their performance so as to—
 - (i) improve the quality of care they provide; and
 - (ii) reduce the incidence of adverse outcomes; and
 - (d) facilitating and monitoring the implementation of any such recommendations.

Under section 54 of the Health Practitioners Competence Assurance Act 2003, this notice remains in force for a period of 5 years after the date on which it is issued, unless it is sooner revoked.

An earlier notice (SR 2004/262) declared The Royal Australian and New Zealand College of Psychiatrists' Peer Review Group Activity to be a protected quality assurance activity. That notice has an expiry date of 26 August 2009 and is revoked.
