# 1 Title

# Description of West Coast Primary Health Organisation Quality Improvement Programme

# 1 Interpretation

In this Schedule,—

**activity** means the West Coast PHO Quality Improvement Programme

**PHO** means Primary Health Organisation.

# 2 Objective

The objective of the activity is to improve the practices and competence of health practitioners engaged in the activity by assessing the health services performed by those health practitioners.

#### 3 Method

The activity is based on information derived from health practitioners participating in West Coast PHO clinical programmes.

#### 4 Activity

The activity involves—

- (a) collecting the following data from health practitioners:
  - (i) aspects of patient care; and
  - (ii) aspects of patient management; and
  - (iii) laboratory test utilisation; and
  - (iv) preventive medicine practices; and
- (b) reviewing and analysing the data collected from each health practitioner under paragraph (a) to identify—
  - (i) the quality of services provided by that health practitioner compared to other health practitioners; and
  - (ii) the effectiveness of the clinical programmes in improving the delivery of health services and outcomes for patients; and
- (c) preparing reports on the results of the review and analysis undertaken under—

- (i) paragraph (b)(i) in relation to each health practitioner participating in the activity; and
- (ii) paragraph (b)(ii) in relation to all health practitioners participating in the activity; and
- (d) visiting health practitioners and discussing with each practitioner how the quality of services he or she provides may be improved; and
- (e) discussing systemic issues arising from the reports prepared under paragraph (c) to—
  - (i) assist with the development of quality improvement plans; and
  - (ii) improve the performance of health practitioners in delivering health services; and
- (f) recommending improvements to—
  - (i) quality improvement plans; and
  - (ii) clinical programmes; and
- (g) monitoring the implementation of any recommendations made under paragraph (f).

# **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, declares the quality assurance activity called the West Coast Primary Health Organisation Quality Improvement Programme to be a protected quality assurance activity. The effect of this declaration is that, subject to certain exceptions,—

• any information that becomes known solely as a result of the activity is confidential; and

- any documents brought into existence solely for the purposes of the activity are confidential; and
- the persons who engage in the activity in good faith are immune from civil liability.

#### **Notes**

#### 1 General

This is a reprint of the Health Practitioners (Quality Assurance Activity—West Coast Primary Health Organisation) Notice 2007. The reprint incorporates all the amendments to the notice as at 19 April 2012, as specified in the list of amendments at the end of these notes.

Relevant provisions of any amending enactments that have yet to come into force or that contain relevant transitional or savings provisions are also included, after the principal enactment, in chronological order.

# 2 Status of reprints

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

# 3 How reprints are prepared

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked

# 4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as "of this section" and "of this Act")
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
  - indentation
  - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as "the 1st day of January 1999" is now expressed as "1 January 1999")

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
  - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
  - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
