Notice

1 Title

This notice is the Health Practitioners (Quality Assurance Activity: Mercy Hospital Surgical Audit) Notice 2007.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

3 Declaration of protected quality assurance activity

The Mercy Hospital Surgical Audit Quality Assurance Activity described in the Schedule is a protected quality assurance activity.

Schedule Description of Mercy Hospital Surgical Audit Quality Assurance Activity

1 Objective

The objective of the activity is to improve the practices and competence of health practitioners engaged in the activity by assessing the health services performed by those health practitioners.

2 Information

The activity is based on information derived from health practitioners who provide health services at Mercy Hospital Dunedin Limited and who are—

- (a) registered to practise surgery; or
- (b) registered to practise anaesthetics.

3 Method

The activity involves—

(a) completing, in respect of all surgical procedures undertaken at Mercy Hospital Dunedin Limited, surgical audit forms that include information on morbidity, morReprinted as at 6 July 2012 Health Practitioners (Quality Assurance Activity: Mercy Hospital Surgical Audit) Notice 2007

tality, and complications arising from the procedures undertaken; and

- (b) preparing reports on the basis of the information provided in the surgical audit forms; and
- (c) participating in surgical audit meetings convened to review cases and discuss issues arising from the reports referred to in paragraph (b); and
- (d) participating in meetings of the Anaesthetic Department of Mercy Hospital Dunedin Limited to review and discuss anaesthetic complications arising from surgery; and
- (e) making recommendations on how health practitioners who are engaging in the activity can improve their performance so as to—
 - (i) improve the quality of services provided at Mercy Hospital Dunedin Limited; and
 - (ii) reduce the potential for complications to arise from surgical procedures undertaken; and
- (f) facilitating and monitoring the implementation of any such recommendations.

Under section 54(4) of the Health Practitioners Competence Assurance Act 2003, this notice remains in force for a period of 5 years after the date on which it is issued, unless it is sooner revoked.

Notes

1 General

2 Status of reprints

4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as "of this section" and "of this Act")
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
 - indentation
 - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as "the 1st day of January 1999" is now expressed as "1 January 1999")

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
 - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
 - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
