Order

1 Title

This order may be cited as the Housing Restructuring Act (Vesting) Order 1996.

2 Interpretation

(1) In this order—

the Act means the Housing Restructuring and Tenancy Matters Act 1992 **the company** means Housing New Zealand Limited.

(2) Any term or expression which is not defined in this order, but which is defined in the Act, has the meaning given to it by the Act.

Clause 2(1) **the Act**: amended, on 1 July 2006, pursuant to section 5(3) of the Housing Restructuring and Tenancy Matters (Information Matching) Amendment Act 2006 (2006 No 34).

3 Assets of Housing New Zealand Limited to vest in the Crown

The assets specified in the Schedule, being assets—

- (a) that were State housing assets vested in the company pursuant to Part 4 of the Act by the Housing New Zealand Limited Vesting Order 1993 (SR 1993/179); and
- (b) that the shareholding Ministers of the company and the company have agreed, as is shown by an agreement, dated 9 April 1996, between those Ministers and the company, should be vested in the Crown,—

are hereby vested in the Crown on 24 May 1996.
