# Proposal for transfer of assets and liabilities from the Crown (acting through the Ministry of Health) to DHBs

cl 3

### 1 Background

This proposal has been prepared in accordance with section 5 of the Health Sector (Transfers) Act 1993 for the purpose of transferring assets and liabilities of the Crown (acting through the Ministry of Health) to DHBs.

### 2 Interpretation

In this proposal, unless the context otherwise requires,—

**assigned number** means the number by which a document held in the Ministry of Health's database of provider contracts is identified in that database

**relevant services**, in relation to a specified notice, means services provided on terms and conditions that are governed by the notice

**specified agreement** means an agreement for the supply of services that is evidenced by, or referred to in, a document identified in Appendix 1

specified notice means a notice, as amended from time to time, that—

- (a) has been, or is deemed to have been, issued under section 88 of the New Zealand Public Health and Disability Act 2000; and
- (b) is identified in Appendix 2.

### 3 Transferor

The transferor is the Crown (acting through the Ministry of Health).

#### 4 Transferees

The relevant transferee,—

- (a) in relation to any specified agreement, is the DHB whose name appears above the table in Appendix 1 that refers to a document that evidences or refers to the agreement; and
- (b) in relation to a specified notice, is the DHB in whose geographical area relevant services are provided.

### 5 Description of assets and liabilities to be transferred

- (1) The assets and liabilities to be transferred are the rights, liabilities, and obligations of the transferor under every specified agreement and every specified notice.
- (2) However, the liabilities referred to in subclause (1) do not include the transferor's liabilities to pay for services provided before 1 July 2001.

## Values attributed for purposes of transfer to assets and liabilities to be transferred

- (1) The value attributed to the assets to be transferred is nil as at 30 June 2001.
- (2) The value attributed to the liabilities to be transferred is nil as at 30 June 2001.

### 7 Transfer of assets without consideration

The assets referred to in clause 5 of this proposal are transferred without the transferor receiving any asset in return.

### 8 Transfer of liabilities for consideration only of transfer of assets

Each transferee is to incur the liabilities referred to in clause 5 of this proposal for consideration only of receiving the assets referred to in that clause.

### 9 Transfer date

The transfer date is 1 July 2001.

### 10 Date and execution

This proposal is dated 9 June 2001 and is signed by the transferring Ministers, Michael John Cullen, Minister of Finance, and Annette Faye King, Minister of Health.

## **Explanatory note**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 July 2001, approves a proposal that has been prepared in accordance with section 5 of the Health Sector (Transfers) Act 1993. The effect of the order is to transfer to District Health Boards the rights and obligations of the Crown (acting through the Ministry of Health) under certain arrangements with providers of health services and disability support services. However, the Crown (acting through the Ministry of Health) remains liable to pay for services provided, before 1 July 2001, under those arrangements.

#### **Notes**

#### 1 General

This is a consolidation of the Health Sector Transfers (Provider Arrangements) Order 2001 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.
