#### Order

#### 1 Title

This order is the Health Sector Transfers (Provider Arrangements) Order (No 2) 2001.

#### 2 Commencement

This order comes into force on 1 October 2001.

## 3 Interpretation

In this order, unless the context otherwise requires,—

proposal means the proposal set out in the Schedule

**relevant transferee**, in relation to any assets or liabilities, means the DHB to which those assets or liabilities are transferred by this order

**relevant transferor**, in relation to any assets or liabilities, means the Crown (acting through the Ministry of Health) or the DHB from which those assets or liabilities are transferred by this order

**supplier**, in relation to a relevant transferee, means a supplier of services that relate to assets or liabilities transferred to the transferee by this order.

#### 4 Proposal approved

The proposal is approved.

## 5 Date on which proposal takes effect

The proposal takes effect on 1 October 2001.

#### 6 Provision facilitating transfer of assets and liabilities

It is declared that, on and from 1 October 2001,—

- (a) every reference to a relevant transferor in any specified agreement (as that term is defined in the proposal) and in any related document is deemed to be a reference to the relevant transferee; and
- (b) each relevant transferee assumes, in relation to assets or liabilities transferred to the transferee by this order, the rights and obligations of the relevant transferor in respect of applications for rights, objections, or proceedings before any court, authority, or other person; and
- (c) each relevant transferee has the obligation to advise each supplier of the address of the office to which invoices must be sent for processing; and

(d) this order is deemed to be notice to all persons, and specific notice need not be given to any authority or other person.

## Schedule Proposal for transfer of assets and liabilities

cl 4

### 1 Background

This proposal has been prepared in accordance with section 5 of the Health Sector (Transfers) Act 1993 for the purpose of transferring—

- (a) certain assets and liabilities of the Crown (acting through the Ministry of Health) to DHBs; and
- (b) certain assets and liabilities between DHBs.

## 2 Interpretation

In this proposal, unless the context otherwise requires,—

**assigned number** means the number by which a document held in the Ministry of Health's database of provider contracts is identified in that database

**specified agreement** means an agreement for the supply of services that is evidenced by, or referred to in, a document identified in Appendix 1 or Appendix 2.

## 3 Transferor

#### The relevant transferor,—

- (a) in relation to any specified agreement that is evidenced by, or referred to in, a document identified in Appendix 1, is the Crown (acting through the Ministry of Health); and
- (b) in relation to any specified agreement that is evidenced by, or referred to in, a document identified in any row of Appendix 2, is the DHB named in column 4 of that row.

#### 4 Transferee

### The relevant transferee,—

- (a) in relation to any specified agreement that is evidenced by, or referred to in, a document identified in Appendix 1, is the DHB whose name appears above the table in which that document is identified; and
- (b) in relation to any specified agreement that is evidenced by, or referred to in, a document identified in any row of Appendix 2, is the DHB named in column 5 of that row.

#### 5 Description of assets and liabilities to be transferred

(1) The assets and liabilities to be transferred are the rights, liabilities, and obligations of the relevant transferor under each specified agreement.

(2) However, the liabilities referred to in subclause (1) do not include the transferors's liabilities to pay for services provided before 1 October 2001.

## **Values attributed for purposes of transfer to assets and liabilities to be transferred**

- (1) The value attributed to the assets to be transferred is nil as at 30 June 2001.
- (2) The value attributed to the liabilities to be transferred is nil as at 30 June 2001.

#### 7 Transfer of assets without consideration

The assets referred to in clause 5 of this proposal are transferred without the transferor receiving any asset in return.

## 8 Transfer of liabilities for consideration only of transfer of assets

Each transferee is to incur the liabilities referred to in clause 5 of this proposal for consideration only of receiving the assets referred to in that clause.

#### 9 Transfer date

The transfer date is 1 October 2001.

#### 10 Date and execution

This proposal is dated 12 September 2001 and is signed by the transferring Ministers, Michael John Cullen, Minister of Finance, and Annette Faye King, Minister of Health.

## **Explanatory note**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 October 2001, approves a proposal that has been prepared in accordance with section 5 of the Health Sector (Transfers) Act 1993. The effect of the order is twofold. First, to transfer to District Health Boards the rights and obligations of the Crown (acting through the Ministry of Health) under certain arrangements with providers of health services and disability support services. Second, to reallocate arrangement of that kind between DHBs. In both cases, the transferor concerned remains liable to pay for services provided, before 1 October 2001, under those arrangements.

#### **Notes**

#### 1 General

This is a consolidation of the Health Sector Transfers (Provider Arrangements) Order (No 2) 2001 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.
