These regulations are the Immigration Amendment Regulations 2006.

These regulations come into force on 24 July 2006.

**Explanatory note**

These regulations amend Part 1 of Schedule 3 of the Immigration Regulations 1999, which sets out the fees payable for applications and other matters specified in that Part.

Two sets of fees for certain visitor and limited purpose permits and visas are reduced from \$85 to \$80, while the fee for applications made in New Zealand for further limited purpose permits for study

purposes is increased from \$70 to \$120. The fee charges take effect on 24 July 2006.
