**1 Title**

These regulations are the Immigration Amendment Regulations 2007.

**2 Commencement**

These regulations come into force on 15 March 2007.

**3 Principal regulations amended**

These regulations amend the Immigration Regulations 1999.

Part 1 of Schedule 3 is amended by adding the following items:

### **Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations come into force on 15 March 2007. They amend Part 1 of Schedule 3 of the Immigration Regulations 1999, which sets out the fees payable for certain applications and other matters specified in that Part.

The amendment prescribes the fees payable for an application for recognised seasonal employer status and for an application for an agreement to recruit under the recognised seasonal employer work policy.
