## Order

### 1 Title

This order is the Income Tax (Minimum Family Tax Credit) Order 2015.

### 2 Commencement

This order comes into force on 1 April 2016.

### 3 Increase of prescribed amount in formula for minimum family tax credit

(1) The amount appearing as an item in the formula for the minimum family tax credit in section ME 1(3)(a) of the Income Tax Act 2007 is increased to \$23,764.

(2) Subclause (1) applies in respect of the 2016/17 tax year.

Clause 3(2): amended, on 1 April 2017, by clause 4(2) of the Income Tax (Minimum Family Tax Credit) Order 2016 (LI 2016/282).

### 4 Amendment to Income Tax (Minimum Family Tax Credit) Order 2014

(1) This clause amends the Income Tax (Minimum Family Tax Credit) Order 2014.

(2) In clause 3(2), delete “and later tax years”.

### 5 Income Tax (Minimum Family Tax Credit) Order 2013 revoked

The Income Tax (Minimum Family Tax Credit) Order 2013 (SR 2013/438) is revoked.
