Explanatory memorandum

This memorandum is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 30 March 2023, amends the Local Government Members (2022/23) Determination 2022.

This determination amends the item relating to Buller District Council in Part 2 of Schedule 2 by—

- updating the annual remuneration amounts and applicable dates for 5 existing offices; and
- inserting the office of Councillor Who is Chairperson of the Inangahua Community Board.

These amendments result from the appointment of a Buller District Council councillor to the office of Chairperson of the Inangahua Community Board.
