Explanatory memorandum

This memorandum is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 12 July 2023, amends the Local Government Members (2023/24) Determination 2023.

This determination amends the item relating to Hamilton City Council in Part 2 of the Schedule by—

- increasing the annual remuneration amounts for 5 offices; and
- updating the number of members in the offices of Chair of Committee of the Whole and Deputy Chair of Committee of the Whole; and
- removing the office of Senior Chair.

These amendments are made at the request of the council concerned and approved by the Remuneration Authority.
