Local Government Members (2023/24) Amendment Determination (No 2) 2024: revoked, on 1 July 2024, pursuant to clause 16 of the Local Government Members (2024/25) Determination 2024 (SL 2024/124).

#### 1 Title

This determination is the Local Government Members (2023/24) Amendment Determination (No 2) 2024.

#### 4 Schedule amended

(1) In the Schedule, Part 2, item relating to Hamilton City Council, replace the items relating to Deputy Mayor, Chair of Committee of the Whole, Chair of the Regulator and Hearings Committee, Deputy Chair of Committee of the Whole, and Councillor with no additional responsibilities with:

# **Explanatory memorandum**

This memorandum is not part of the determination but is intended to indicate its general effect.

This determination amends the Local Government Members (2023/24) Determination 2023 (the **principal determination**).

The amendments relating to Hamilton City Council are deemed to have come into force on 15 March 2024, the amendment relating to Manawatu District Council is deemed to have come into force on 8 March 2024, and the insertion of Tauranga City Council into Part 2 of the Schedule of the principal determination is deemed to have come into force on 1 March 2024.

This determination amends Part 2 of the Schedule of the principal determination by—

- reflecting the change that Hamilton City Council made to its governance structure and adjusting the annual remuneration amounts to reflect its new structure:
- reflecting the change that Manawatu District Council made to its Deputy Mayor's title:
- inserting the remuneration for the Mayor and Councillor (minimum allowable remuneration) for Tauranga City Council, to inform the Council and the candidates who will be standing in the forthcoming Council elections to be held on 20 July 2024.

Note that no changes were made to the councils' governance remuneration pools as shown in the explanatory memorandum that is appended to the principal determination.

The amendments in this determination are made at the request of the councils concerned and approved by the Remuneration Authority.

#### 1 General
