Land Transfer Amendment Regulations 2004: revoked, on 12 November 2018, pursuant to section 249(1) of the Land Transfer Act 2017 (2017 No 30).

Pursuant to sections 235 and 236 of the Land Transfer Act 1952, Her Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

### 1 Title

- (1) These regulations are the Land Transfer Amendment Regulations 2004.
- (2) In these regulations, the Land Transfer Regulations 2002<sup>1</sup> are called "the principal regulations".

### 2 Commencement

These regulations come into force on 5 July 2004.

These regulations, which come into force on 5 July 2004, amend the Land Transfer Regulations 2002 by substituting a new schedule of fees payable under the Land Transfer Act 1952. The main features of new Schedule 5 are as follows:

- the Schedule is restructured to provide a more logical sequence:
- some items have been deleted or merged with others:
- most fees are reduced.
