## Regulations

### 1 Title

- (1) These regulations are the Land Transport (Driver Licensing and Driver Testing Fees) Amendment Regulations 2001.
- (2) In these regulations, the Land Transport (Driver Licensing and Driver Testing Fees) Regulations 1999<sup>1</sup> are called “the principal regulations”.

### 2 Commencement

These regulations come into force on 31 December 2001.

### 3 Schedule amended

The Schedule of the principal regulations is amended by—

- (a) revoking Parts 1 to 4, and substituting Parts 1 to 4 as set out in Schedule 1 of these regulations:
- (b) revoking Part 7, and substituting Part 7 as set out in Schedule 2 of these regulations:
- (c) revoking Parts 9 to 11, and substituting Parts 9 to 11 as set out in Schedule 3 of these regulations.
