## **Regulations**

### **1 Title**

These regulations are the Land Transport (Driver Licensing and Driver Testing Fees) Amendment Regulations 2012.

### **2 Commencement**

These regulations come into force on 5 July 2012.

### **3 Principal regulations**

These regulations amend the Land Transport (Driver Licensing and Driver Testing Fees) Regulations 1999 (the **principal regulations**).

### **4 Application**

- (1) Regulation 5(1) and Part 1 of the Schedule apply during the period beginning on 5 July 2012 and ending with the close of 4 July 2015.
- (2) Regulation 5(2) and Part 2 of the Schedule apply on and after 5 July 2015.

### **5 Schedule amended**

- (1) Amend the Schedule of the principal regulations as set out in Part 1 of the Schedule of these regulations.
- (2) Amend the Schedule of the principal regulations as set out in Part 2 of the Schedule of these regulations.

**Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 5 July 2012, amend the Schedule of the Land Transport (Driver Licensing and Driver Testing Fees) Regulations 1999 (the **principal regulations**) to increase certain driver licensing fees and driver testing fees.

*Regulation 5(1) and Part 1 of the Schedule* increase the fees for the following driver licensing and driver testing fees specified in Part 1 and Part 4 of the Schedule of the principal regulations during the period beginning on 5 July 2012 and ending with the close of 4 July 2015 as follows:

- the fee to obtain a learner or restricted licence of Class 1 or 6 is increased from \$48.20 to \$48.70:
- the fee to obtain a full licence of Class 1 or 6 is increased from \$49.60 to \$50.00:
- the fee to undertake tests required for a learner licence of Class 1 or 6 is increased from \$45.70 to \$47.40:
- the fee to undertake tests required for a restricted licence is increased from \$86.60 to \$88.30:
- the fee to undertake tests required for a full licence of Class 1 or 6 is increased from \$59.90 to \$61.70.

*Regulation 5(2) and Part 2 of the Schedule* reinstate the fees that applied before 5 July 2012 in respect of applications for the relevant licences and tests made on or after 5 July 2015.

## Notes

### **1** *General*

This is a consolidation of the Land Transport (Driver Licensing and Driver Testing Fees) Amendment Regulations 2012 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.
