Regulations

1 Title

These regulations are the Legislation (Official Versions) Regulations 2013.

2 Commencement

These regulations come into force on 5 August 2013.

3 Features of official versions of legislation

- (1) This regulation specifies the features that identify official versions of legislation that the Chief Parliamentary Counsel may issue under section 17 of the Legislation Act 2012.
- (2) This regulation applies to—
 - (a) versions of legislation issued by the Chief Parliamentary Counsel in portable document format (PDF) on the New Zealand Legislation website (www.legislation.govt.nz); and
 - (b) printed versions of legislation issued by the Chief Parliamentary Counsel or issued on his or her behalf by a contracted printer.
- (3) An official version of legislation—
 - (a) must display or exhibit on its front page a representation of the New Zealand Coat of Arms; and
 - (b) may contain a statement to the effect that the legislation—
 - (i) is issued under the authority of the New Zealand Government; or
 - (ii) is issued under the authority of the Legislation Act 2012 or was originally issued under the Acts and Regulations Publication Act 1989 or a corresponding former Act.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect. These regulations, which come into force on 5 August 2013, prescribe the features of official versions of legislation.

The regulations provide that the New Zealand Coat of Arms is the distinguishing feature of official versions of legislation issued by the Chief Parliamentary Counsel under the Legislation Act 2012. Another familiar feature may also appear on official versions of legislation, namely, a statement to the effect that the legislation is issued under the authority of the New Zealand Government or the Legislation Act 2012.
