**2 Validation of unlawful election**

Notwithstanding that an election of parent representatives for the Board of Governors of McKillop College was required by regulation 7 of the Secondary School Boards Administration and Employment Regulations 1965 to be held not later than the 23rd day of July 1984, the holding of that election on the 15th day of August 1984 is hereby validated.

This order validates the holding of an election for parent representatives for the Board of Governors of McKillop College in Rotorua. The election was required by law to be held not later than 23 July 1984 but was not held until 15 August 1984.
