# New Zealand Council for Educational Research (Electoral College) Order 1998

(SR 1998/336)

New Zealand Council for Educational Research (Electoral College) Order 1998: revoked, on 21 May 2009, by clause 4 of the New Zealand Council for Educational Research (Electoral College) Order 2009 (SR 2009/92).

PURSUANT to section 21(2) of the New Zealand Council for Educational Research Act 1972, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Minister of Education, makes the following order.

**1 Title and commencement**

- (1) This order may be cited as the New Zealand Council for Educational Research (Electoral College) Order 1998.

- (35) Not more than 8 chief executives of polytechnics, nominated by the executive committee of the Association of Polytechnics of New Zealand.

Subclause (11) was amended, as from 1 August 2000, by clause 4(2) Education (Change of Name of Education Entities) Order 2000 (SR 2000/117) by substituting the words “Skill New Zealand” for the words “the Education and Training Support Agency”.

Subclause (11) was substituted, as from 1 January 2003, by section 59 Education (Tertiary Reform) Amendment Act 2002 (2002 No 50).

Subclause (12) was amended, as from 1 August 2000, by clause 4(2) Education (Change of Name of Education Entities) Order 2000 (SR 2000/117) by substituting the words “Early Childhood Development Board” for the words “Early Childhood Development Unit”.

Subclauses (9) and (10) were substituted, as from 7 June 2001, by clause 3(2) New Zealand Council for Educational Research (Electoral College) Amendment Order 2001 (SR 2001/86).

### **3 Changes of name**

Every reference in clause 2 to a body that changed its name after the commencement of the Educational Research (Electoral College) Order 1994<sup>1</sup> or that changes its name after the commencement of this order is to be read as a reference to that body under its name for the time being.

### **4 Consequential revocation**

The New Zealand Council for Educational Research (Electoral College) Order 1994 is consequentially revoked.
