2 Commencement of New Zealand Sports Drug Agency Amendment Act 2000

The New Zealand Sports Drug Agency Amendment Act 2000 comes into force on 12 April 2001.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order brings the New Zealand Sports Drug Agency Amendment Act 2000 into force on 12 April 2001. That Act amends the New Zealand Sports Drug Agency Act 1994 to—

- provide for circumstances where specified drugs or doping methods (or levels of them) that are otherwise banned for the purposes of the Act are not banned:
- provide that positive test results cannot be overturned by irregularities in the sampling and testing procedures that do not affect the identity or integrity of the sample:
- allow the New Zealand Sports Drug Agency to conduct out-of-competition testing of New Zealand competitors on behalf of an overseas anti-doping or sports organisation.
