# Periodic Detention Order (No 4) 1973

(SR 1973/204)

Periodic Detention Order (No 4) 1973: revoked, on 6 November 2008, by clause 3 of the Regulations Revocation Order 2008 (SR 2008/367).

PURSUANT to section 2 of the Criminal Justice Amendment Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### **1 Title and commencement**

- (1) This order may be cited as the Periodic Detention Order (No 4) 1973.
- (2) This order shall come into force on the 17th day of August 1973.

**This order is administered in the Department of Justice.**

**2 Nelson**

- (1) Section 9 and sections 11 to 15 of the Criminal Justice Amendment Act 1962 shall apply with respect to male offenders who are of or over the age of 16 years and—
- (a) Who are convicted after the commencement of this order—
    - (i) In the High Court at Nelson; or
    - (ii) By a Magistrate's Court held at Nelson; or
  - (b) Against whom a charge is proved after the commencement of this order in a Children's Court held at Nelson.
- (2) Sections 10 to 15 of the said Act shall apply with respect to male offenders who are of or over the age of 16 years and in respect of whom—
- (a) An order for imprisonment may be made after the commencement of this order, pursuant to section 19D of the Crimes Act 1961, by a Judge of the High Court at Nelson by reason of the non-payment of a fine imposed on or after the 1st day of October 1966; or
  - (b) A warrant of commitment may be issued after the commencement of this order by a Magistrate exercising jurisdiction in a Magistrate's Court held at Nelson in respect of a fine imposed on or after the 15th day of July 1963.

Subclauses (1)(a)(i) and (2)(a) were amended, as from 1 January 2004, by section 48(3) Supreme Court Act 2003 (2003 No 53) by substituting the word "High" for the word "Supreme". See sections 50 to 55 of that Act for the transitional and savings provisions.
