## **Explanatory note**

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, inserts the name Research and Education Advanced Network New Zealand Limited into Schedule 4 of the Public Finance Act 1989. Adding Research and Education Advanced Network New Zealand Limited to Schedule 4 means that, under sections 45M and 45N of the Public Finance Act 1989, certain provisions of the Crown Entities Act 2004 apply to the company as if it were a Crown entity under the Crown Entities Act 2004.
