1 Title and commencement

- (1) This notice may be cited as the Penal Institutions Notice (No 2) 1986.

- (1) The land described in Schedule 1 to this notice, which was declared by clause 2 of the Penal Institutions Notice 1985 (SR 1985/1) to be added to the prison known as Mount Eden Prison (SR 1968/232), is hereby declared to be excluded from that prison.
- (2) The Penal Institutions Notice 1985 (SR 1985/1) is hereby consequentially revoked.
