## Order

### 1 Title and commencement

- (1) This order may be cited as the Public Service Investment Society Management Order (No 2) 1981.
- (2) This order shall come into force on 1 May 1981.

### 2 Act to cease to apply to Walker's Travel Centre (1972) Limited

It is hereby declared that the Public Service Investment Society Management Act (No 2) 1979 shall cease to apply to Walker's Travel Centre (1972) Limited from the commencement of 1 May 1981.

## Explanatory note

*This note is not part of the order, but is intended to indicate its general effect.*

This order provides that the Public Service Investment Society Management Act (No 2) 1979 shall cease to apply to Walker's Travel Centre (1972) Limited from the commencement of 1 May 1981.

## Notes

### **1**    *General*

This is a consolidation of the Public Service Investment Society Management Order (No 2) 1981 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

### **2**    *Legal status*

A consolidation is taken to correctly state, as at its stated date, the law enacted or made by the legislation consolidated and by the amendments. This presumption applies unless the contrary is shown.
