Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 July 2013, amends section 3(1) of the Rates Rebate Act 1973. Section 3(1) provides for the payment of rates rebates to certain residential ratepayers. This order increases the maximum rebate from \$590 to \$595 and the income abatement threshold for calculating rebates from \$23,650 to \$23,870.
