This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 21 January 1994, revokes 4 notices and 1 order that have ceased to have effect.

Three of the notices established pre-release hostels under the Penal Institutions Amendment Act 1978. That Act has been repealed.

The enactments under which the Customs Duties (Timber) Suspension Order 1974 was made have been repealed, and the regulations under which the Export Licences Exemption Notice 1982 was made have been revoked.
