1 Title and commencement

2 Interpretation

Clause 2(1) of the principal notice is amended by revoking paragraph (a)(ii) of the definition of the term **Australian is-suer**, and substituting the following subparagraph:

"(ii) Named in Schedule 1; and."

3 Conditions of exemption

Clause 4 of the principal notice is amended by omitting the word "The" in the first place where it appears, and substituting the words "Except as otherwise provided in clause 5, the".

4 Modified application of conditions of exemption

The principal notice is amended by inserting, after clause 4, the following clause:

"5

Nothing in clause 4(b) or (c) applies in respect of any offer of specified securities of a company named in Schedule 2."

5 New Schedules 1 and 2 substituted

- (1) The principal notice is amended by revoking the Schedule, and substituting Schedules 1 and 2 set out in the Schedule of this notice.
- (2) Clause 3 of the Securities Act (Listed Australian Issuers Employee Share Schemes) Exemption (No 2) Amendment Notice 1998 is consequentially revoked.
