1 Title

These regulations are the Student Allowances Amendment Regulations 2021.

2 Commencement

These regulations come into force on 1 April 2021.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect. These regulations, which come into force on 1 April 2021, amend the Student Allowances Regulations 1998 to increase the rates of the basic grants and independent circumstances grants, and to raise income thresholds. The new rates reflect a 1.15% increase in the New Zealand Consumers Price Index from the December 2019 quarter to the December 2020 quarter (calculated for all quarters using the New Zealand Consumers Price Index (All Groups), excluding cigarettes and other tobacco products).

Notes

1 General

This is a consolidation of the Student Allowances Amendment Regulations 2021 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

2 Legal status
