1 Title and commencement

- (1) This order may be cited as the State-Owned Enterprises (Department of Lands) Order 1987.
- (2) This order shall come into force on the 1st day of January 1988.

2 Extension of transitional arrangements

It is hereby declared that Part 3 of Schedule 4 to the State-Owned Enterprises Act 1986 shall continue to have effect after the 31st day of December 1987 until the 31st day of December 1988.
