# Regulations

#### 1 Title

These regulations are the Student Loan Scheme (Repayment Threshold) Regulations 2018.

## 2 Commencement

These regulations come into force on 1 April 2019.

# 3 Annual repayment threshold

The amount of the annual repayment threshold for the tax year commencing on 1 April 2019 and subsequent tax years is \$19,760.

## 4 **Revocations**

The Student Loan Scheme (Repayment Threshold) Regulations 2016 (LI 2016/295) and the Student Loan Scheme (Repayment Threshold) Regulations 2017 (LI 2017/309) are revoked.

# **Explanatory note**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2019, increase the annual repayment threshold for the purposes of the Student Loan Scheme Act 2011 from \$19,448 to \$19,760.

These regulations also revoke the Student Loan Scheme (Repayment Threshold) Regulations 2016 and the Student Loan Scheme (Repayment Threshold) Regulations 2017.
