Regulations

1 Title and commencement

- (1) These regulations may be cited as the Ship Registration (Fees) Regulations 1992.
- (2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2 Interpretation

In these regulations, unless the context otherwise requires, the Act means the Ship Registration Act 1992

Director means the Director of Maritime New Zealand; and includes the deputy of the Director.

3 Fees

- (1) There shall be paid for the issue of the documents specified in the Schedule, and for the other matters specified in the Schedule, the fees specified in that schedule.
- (2) The fees set out in—
 - (a) the second column of the Schedule are payable for the documents and matters described in the first column of that schedule for the 8 months starting on 1 November 2008:
 - (b) the third column of the Schedule are payable for the documents and matters described in the first column of

that schedule for the year starting on 1 July 2009 and subsequent years.

Regulation 3(2): added, on 1 November 2008, by regulation 4 of the Ship Registration (Fees) Amendment Regulations 2008 (SR 2008/321).

4 Director may refund or waive fees

The Director may authorise the refund or waiver of any fee, in whole or in part, where the ship in respect of which the fee is payable—

- (a) is operated principally for training purposes on a national basis by an incorporated society or a charitable trust; or
- (b) is operated principally for search and rescue purposes. Regulation 4: substituted, on 20 August 1993, by section 20(2) of the Maritime Transport Act 1993 (1993 No 89).

5 Fees inclusive of goods and services tax

The fees prescribed by these regulations are inclusive of goods and services tax payable under the Goods and Services Tax Act 1985.

Notes

1 General

This is a reprint of the Ship Registration (Fees) Regulations 1992. The reprint incorporates all the amendments to the regulations as at 1 July 2013, as specified in the list of amendments at the end of these notes.

2 Status of reprints

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

3 How reprints are prepared

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked

4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as "of this section" and "of this Act")
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
 - indentation
 - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as "the 1st day of January 1999" is now expressed as "1 January 1999")

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
 - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
 - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
