## Regulations

1 Title

These regulations are the Social Security (Childcare Assistance) Amendment Regulations 2012.

### 2 Commencement

These regulations come into force on 1 April 2012.

#### **3** Principal regulations

These regulations amend the Social Security (Childcare Assistance) Regulations 2004 (the **principal regulations**).

### 4 Schedule 1 amended

# **Explanatory note**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2012, amend the Social Security (Childcare Assistance) Regulations 2004, by increasing the rates of childcare and OSCAR (out-of-school care and recreation) subsidies available to certain caregivers with dependent children.

The increases reflect a 1.77% increase in the New Zealand Consumers Price Index from the December 2010 quarter to the December 2011 quarter (calculated for all quarters using the CPI All Groups excluding cigarettes and other tobacco products).

### 1 General

This is a reprint of the Social Security (Childcare Assistance) Amendment Regulations 2012. The reprint incorporates all the amendments to the regulations as at 1 April 2013, as specified in the list of amendments at the end of these notes.

## 2 Status of reprints

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. ## 4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for
