## Regulations

### 1 Title and commencement

- (1) These regulations may be cited as the Secondary Schools Bursaries Regulations 1977.
- (2) These regulations shall come into force on the day after their notification in the *Gazette*.

### 2 Interpretation

In these regulations, unless the context otherwise requires,—  
**bursary** means a bursary awarded pursuant to these regulations

**Minister** means the Minister of Education

**Secretary** means the Secretary of Education.

Regulation 2 **Director-General**: revoked, on 1 October 1989, pursuant to section 144(2) of the Education Act 1989 (1989 No 80).

Regulation 2 **Secretary**: inserted, on 1 October 1989, pursuant to section 144(2) of the Education Act 1989 (1989 No 80).

### 3 Bursaries

The Secretary may award bursaries in accordance with these regulations to enable pupils to attend State secondary schools or registered private secondary schools.

#### **4 Applications**

- (1) Applications for bursaries shall be made to the Secretary on forms provided for the purpose by the Ministry of Education.
- (2) Except where the Secretary is satisfied that there are special circumstances, no such application shall be considered unless it is received by the Secretary on or before 31 March of the year to which it relates.
- (3) Every such application shall be accompanied by a birth certificate or other evidence of the age of the applicant.

#### **5 Qualification**

The Secretary shall not award a bursary to any applicant unless:

- (a) either he has been accredited for or has passed the University Entrance Examination or has obtained some other qualification recognised by the Secretary as being of equivalent status, or he has achieved such a standard in the School Certificate Examination as the Secretary may think adequate; and
- (b) the Secretary is satisfied that, in order to attend the nearest school affording satisfactory tuition at sixth form or seventh form level, the applicant would be obliged to live away from home or his usual place of residence; and
- (c) the applicant was under the age of 18 years on 15 January in the year to which his application relates.

#### **6 Applicant holding other bursary**

- (1) Except with the authority of the Secretary, given after consideration of the special circumstances of any case, no person

shall hold any bursary while he is the holder of any other bursary, or while he is the holder of any scholarship or of any grant or allowance (by whatever name called) made for the purpose of assisting him to pursue his studies at any school, university, or other educational institution.

- (2) Where any person holds concurrently a bursary and any other bursary, scholarship, grant, or allowance, the value of the bursary may be reduced by such amount as the Secretary considers reasonable in the circumstances.

## **7 Tenure**

- (1) Bursaries shall be tenable only at schools approved for accrediting purposes in respect of 1985 by the University Entrance Board.
- (2) Subject to subclause (1), a bursary shall be tenable at any school:

provided that, except in special circumstances, the Secretary shall not approve the holding of a bursary at any school that is not situated in the education district where the home or usual place of residence of the holder is situated.

## **8 Employment**

It shall be a condition of every bursary that the holder shall not, while the school at which he is enrolled as a pupil is in session, be engaged in any occupation except with the consent of the Secretary.

## **9 Value and term of bursary**

## **10 Payment**

- (1) No payment in respect of a bursary shall be made unless the Secretary is satisfied that the holder has complied with the conditions subject to which the bursary was awarded.
- (2) Subject to the provisions of these regulations, payments in respect of bursaries shall be made to the holders by such instalments, as the Secretary may determine.
- (3) On the application of the holder of any bursary the Secretary may in special cases suspend the payment of the bursary for such period or periods as he thinks fit; and a period during which the bursary is so suspended shall not be taken into account in computing the term of the bursary.

## **11 Reports by Principals**

The Principal of a school at which the holder of a bursary is for the time being enrolled as a pupil shall furnish to the Secretary, when required by him to do so, a report in writing as to the progress of the holder in his course of study, and generally as to his compliance with the conditions subject to which the bursary is held.

## **12 Forfeiture of bursaries**

- (1) Subject to subclause (2), a bursary shall be forfeited at any time if, in the opinion of the Secretary:
  - (a) the holder fails to attend school regularly; or
  - (b) the holder has not been accredited for or has not passed either the University Entrance Examination or some

- other qualification recognised by the Secretary as being of equivalent status prior to the award of the bursary and fails at the end of the first year of the bursary to be accredited for or to pass the University Entrance Examination or obtain such a qualification; or
- (c) the holder fails to make satisfactory progress in his studies; or
  - (d) the holder commits any serious breach of the rules of the school at which he is enrolled or is guilty of any serious misconduct.
- (2) No bursary shall be forfeited pursuant to paragraph (a), or paragraph (b), or paragraph (c) of subclause (1) if satisfactory evidence is produced to the Secretary that the failure of the holder was due to his illness or to some other sufficient cause beyond his control.
- (3) The Secretary may determine or reduce the payments made pursuant to a bursary if, in his opinion, the circumstances of the holder no longer justify the granting of that financial assistance or, as the case may be, of financial assistance to that extent.

- 4 Transitional provisions**  
Despite clause 3,—
  - (a) the terms and conditions of any bursary or scholarship awarded to a student before the commencement of this order under any of the regulations specified in the Schedule are unaffected by this order; and
  - (b) the regulations specified in the Schedule continue to apply to any bursary or scholarship awarded to a stu-

**Notes****1 General**

This is a reprint of the Secondary Schools Bursaries Regulations 1977. The reprint incorporates all the amendments to the regulations as at 1 June 2013, as specified in the list of amendments at the end of these notes.

Relevant provisions of any amending enactments that contain transitional, savings, or application provisions that cannot be compiled in the reprint are also included, after the principal enactment, in chronological order. For more information, see <http://www.pco.parliament.govt.nz/reprints/>.

**2 Status of reprints**

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

**3 How reprints are prepared**

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked

are omitted. For a detailed list of the editorial conventions, see <http://www.pco.parliament.govt.nz/editorial-conventions/> or Part 8 of the *Tables of New Zealand Acts and Ordinances and Statutory Regulations and Deemed Regulations in Force*.

#### **4 Changes made under section 17C of the Acts and Regulations Publication Act 1989**

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as “of this section” and “of this Act”)
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
  - indentation
  - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as “the 1st day of January 1999” is now expressed as “1 January 1999”)

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
  - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
  - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
